#### II. Demands

- We demand a thorough, third-party, non-accrediting investigation into RPD to address patterns and practices of unconstitutional policing, intimidation, and excessive use of force.
- 2. We demand that this investigation is followed by the firing of any officers involved in the above practices.
- 3. We demand that all charges against Thria Bernabe be dropped immediately.
- 4. We demand that all police officers wear masks while on duty during the duration of the COVID-19 crisis.
- 5. We demand that Ridgewood begin the process of DEFUNDING the police and INVESTING in racial justice initiatives.

Script for Phone Zap

This pattern of abuse by the Ridgewood Police Department is unacceptable. Ridgewood must begin the process of defunding the police and investing in the community.
